

**MINUTES
FOR THE Special and Emergency Board Meeting
OF THE PRESIDENT AND THE BOARD OF TRUSTEES
OF THE VILLAGE OF ORLAND HILLS, ILLINOIS
FOR DECEMBER 26, 2023**

President Hastings called the hearing to order at 10:00 a.m.

Clerk Iannantone called the roll with the following results. President's Report: President Hastings

Mayor Hastings then announced that the purpose of the Special and Emergency Board meeting was the concern that unscheduled buses of migrants could be dropped off within the corporate limits of the Village and the Board was prepared to pass an Ordinance to address the safety of Village residents and of those passengers on these buses.

Trustee Hastings II expressed disappointment in the Federal and State elected officials for not addressing these concerns on a national and state level and forcing municipalities who do not possess the resources to have to deal with these problems.

Trustee Petrey echoed Trustee Hastings II comments and noted that he did not hold the Governor of Texas responsible for this situation.

Administrator's Report: Administrator O'Neill

Administrator O'Neill requested support of a motion to approve Ordinance number 2023-007, AN ORDINANCE OF THE VILLAGE OF ORLAND HILLS, COOK COUNTY, ILLINOIS ESTABLISHING REGULATIONS FOR UNSCHEDULED INTERCITY BUSES, AND THE DISCHARGE OF PASSENGERS TO ENSURE THE HEALTH, SAFETY AND WELFARE OF RESIDENTS AND VISITORS TO THE VILLAGE OF ORLAND HILLS, as presented.
