

**MINUTES**  
**FOR THE REGULAR BOARD MEETING**  
**OF THE PRESIDENT AND THE BOARD OF TRUSTEES**  
**OF THE VILLAGE OF ORLAND HILLS, ILLINOIS**  
**FOR JUNE 19, 2019**

President Hastings called the meeting to order at 8:00 p.m.

Clerk Iannantone called the roll with the following results. Present: President Hastings. Trustees: Petrey, Janachowski, Morrison, Kissane (8:05), Roti and Hastings II. Administrator Kiebles, Assistant Administrator O'Neill, Asst. PW Director Hanley, EMA Director Leddin and Deputy Chief Blaha. Excused: Chief Scully, and Attorney Norwell. Absent: None. With a quorum having been established, Mayor Hastings led the Pledge of Allegiance and the salute to the flag.
