## 26th Anniversary Of A Balanced Budget

Mayor Kyle R. Hastings recently introduced another balanced budget to the Village Board. The Village Board ratified the budget for the upcoming fiscal year on April 24, 2019. This marks the 26th year in a row that Orland Hills has had a balanced budget.

Orland Hills continues to maintain a healthy balanced budget with the Village Board seeking new revenue sources to keep the tax burden as low as possible for our residents.

Over the last few months, I have personally travelled to Springfield to appear before Legislative committees to promote and lobby for additional municipal revenue. Fortunately, the new legislation that recently passed will provide additional Motor Fuel Taxes for Orland Hills street improvements.

At the direction of the Village administration, our fiscal readiness and stability continues to set us apart from other towns and ensures that economic growth continues as a priority for our community.

"Our Trustees and Village staff have worked very hard to provide high quality services, excellent programs and infrastructure improvements", Mayor Hastings said. "I am proud to have balanced the budget for every consecutive year of the 26 years that I have been in office. It clearly shows we can run our Village like a successful business."

## Lake Lorin Plans Wait for Army Corps Approval

A recent meeting was held at the Chicago offices of the U.S. Army Corps of Engineers to discuss final approval of the Lake Lorin shoreline improvements. Army Corps approval is expected. The USACOE will then recommend to the Illinois Environmental Protection Agency (IEPA) that their approval process be waived so as to allow Lake Lorin plans to proceed in October.

Christopher Burke Engineering, an environmental engineering firm representing the Village at the meeting has completed the permitting application and provided Shoreline Design Assistance.

A Subsurface Investigation Report has been prepared by the Village Engineer which served as a basis for the design of the shoreline restoration plan. Design renderings are available for review in the Village Hall Board Room. Costs, materials and construction methods for the improvements are now under investigation.

Proposed site improvements will include the reconstruction of the shoreline to allow outdoor recreational users to stand on the shoreline and fish in Lake Lorin. Currently, the existing shoreline does not allow for this as the shoreline slopes into the lake.

"The Village is committed to bringing the Lake Lorin shoreline back to a more recreational friendly and aesthetic restoration for Village residents", said Mayor Hastings at the recent Village Board meeting. "We hope to get approval by the Corps very soon and a waiver from the Illinois IEPA to begin construction this fall."

Lake Lorin is a 3.5 acre man-made lake that was created in 1978 and designed for water detention and a convenient passive recreation use facility for fishing, hiking and bird watching.

Lake Lorin is named after recently deceased Mayor Lorin Schaub whose inspired actions helped to create the beautiful open space venue.

## Trustees Return to Village Board

On Tuesday, April 2, 2019, the residents of Orland Hills exercised their constitutional right to elect and return three Trustees to the Orland Hills Village Board. The residents cast their ballot and re-elected Trustees Candice Morrison, Kyle R. Hastings II and Marcia Kissane for another 4-year term.

The oath of office for the newly elected officials was administered at the Village Board meeting on May 15, 2019 by Circuit Court Judge Michael Barrett.

Candice Morrison will enter her 5th term with the most tenure as Trustee. Trustee Morrison serves as the Chairperson of the Youth, Education and Recreation Committee and has directed and continued many accomplishments with family events through the Recreation Department at our outstanding park facilities. Candice is a tireless advocate of the excellent services that our town provides.

Kyle R. Hastings II is entering his 4th term as Trustee. Trustee Hastings II is the Chairman of two Committees; Police & Fire and Special Events. Kyle is instrumental in bringing new events like the Princess in the Park and Touch A Truck to Orland Hills. Trustee Hastings II focuses on Public Safety as the most important service provided to our residents.

Marcia Kissane is beginning her 2nd term as Trustee in our Village. She chairs the Development, Planning and Zoning Committee. Trustee Kissane is no stranger in the Village of Orland Hills having volunteered many hours toward civic activities in the Village.

At the meeting, Mayor Hastings said "This is a great honor to have these three Trustees remain on the Board. It takes an experienced team to work together to make Orland Hills the greatest place to live. Just look at our services; low crime rate, recreational programs and events, fiscal responsibility, good schools and the progress of our Village." Hastings added, the Village Board has come a long way and they will continue to keep improving our Village!"

- Senior Citizens (age 65) Cars -\$99, Trucks - \$10.99. Only one (1) senior price per household.


### **INFORMATION FOR NEW RESIDENTS:**

# Summer Safety Tips

1. Always **check first** with your parents, guardians or a trusted adult before you go anywhere or do anything. Be sure to check in regularly.
2. Always **take a friend** with you. It's safer and more fun.
3. Don't be tricked by people who offer you special gifts or treats. Never accept anything without your parent's permission.
4. Stay **safer** at home by keeping your doors locked. Always know who is at the door before you open the door. If you don't know who's at the door, get your parents before you open it.
5. Never go into a public restroom by yourself.
6. Never go alone to a mall, the movies, the park, or video arcades.
7. Be careful when you play. Stay away from pools, canals, ponds, and other bodies of water unless you are with an adult.
8. Don't play near busy streets, and never get in a car with someone that you don't know.
9. If you ride your bike after dark, use a light and wear reflective clothing.



## BUILDING DEPARTMENT



Today, more utility companies and municipalities that supply power, gas, water, and telecommunications are delivering these services underground. With this in mind, JULIE, Inc. and its members are promoting the importance of calling the Illinois One-Call System before any digging projects and stressing safe-digging practices to professional excavators and homeowners as part of a statewide “Dig Safely Illinois” education campaign.

“According to state law, anyone planning an outdoor project that requires digging, regardless of the depth or the size of the outdoor project, should call JULIE at 1-800-892-0123,” said Kevin Chmura, director of Public Relations at JULIE, Inc. “The call to JULIE and service provided by members are free to the excavator. Call center operators are available to receive and process calls 24 hours a day, seven days a week.”

JULIE, Inc. is a not-for-profit corporation that provides excavators with a toll-free number (1-800-892-0123) for the free locating and marking of underground facilities. JULIE serves as a notification service for underground facility owners, taking information about planned excavations and distributing this information to its membership. It is then the responsibility of each facility owner to mark the location of their underground facilities at the excavation site. JULIE neither owns nor marks any underground facilities.

JULIE, Inc. promotes an easier, safer digging environment and serves the

entire state of Illinois outside of the city of Chicago, which is covered by DIGGER. Illinois law requires anyone digging to call JULIE at least two working days prior to the start of excavation and to begin that project within 14 calendar days from the call. The 48 hour notice does not include Saturdays, Sundays or holidays.

Established in 1974, JULIE represents 1,750 members. JULIE has 100 employees during peak periods and is located in a state of the art facility in Joliet, Illinois. For more information visit [www.illinois1call.com](http://www.illinois1call.com).

### TYPES OF OUTDOOR PROJECTS

Common examples of homeowner projects that require a call to JULIE before digging include putting up a fence, installing a swing set, a mailbox post or new water feature, building of a deck or room addition; preparing a new garden area or adding new trees, bushes or shrubs.

### Mailbox in Bad Shape?

If you notice that your mailbox is in bad shape (rotted, leaning, door broke etc.) Now, with the weather being so nice would be a great time to fix your mailbox!



### Common Courtesy

Please do not block your neighbor’s mailbox. The post office will not deliver to a box that is blocked by your car.

The Village thanks you in advance for being courteous!!

### Mailbox Guidelines



From the wear and tear of daily use to constant assault from the elements, these guidelines will help you set up a mailbox that stands up to it all.

If you are buying a new mailbox, look for the Postmaster General’s seal of approval; every new mailbox designed should be reviewed and approved before it goes

to market. Always run your plans by your local postmaster. Overall, the mailbox you build will need to meet the same size, strength, and quality standards as manufactured boxes. The house numbers should clearly be displayed on your mailbox.

Put a roadside mailbox where a carrier can safely reach inside without leaving the truck. That means positioning it about 41” to 45” off the ground and back about 6” to 8” from the curb.

## BUILDING DEPARTMENT



### Home Improvements

The Building Department is located in the Village Complex, upper level at 16033 S. 94th Avenue. The Village of Orland Hills is always happy to see home improvements! Not only does it add value to your home but also to the homes around you. In order to serve you better, please read the following guidelines prior to making these improvements:

#### How to go about getting a Building Permit?

1. Applications are available to apply for a permit at the Village Hall. Applications can also be downloaded from ([www.orlandhills.org](http://www.orlandhills.org))
2. Complete all information requested on the application (no blank spaces) and submit, if requested, 4 sets of detailed plans and a plat of survey. Plats of survey must be marked with the location of the construction project. Example: Mark on your plat where your patio will be located.
3. Make sure the contractor you have selected is licensed, bonded and insured with the Village of Orland Hills prior to applying for your permit. (If this is not completed, this can sometimes prolong the processing of your permit.) It is important that you tell the contractor up front that he needs to be licensed with the village. Contractor applications can be downloaded from ([www.orlandhills.org](http://www.orlandhills.org))
4. Once all paperwork is properly filled out and submitted, wait time is approximately 4 – 7 business days when it's busy.
5. Absolutely no work is to be started prior to permit approval.
6. The Building Department will contact you when your permit has been approved and is available for pick up.
7. Place the permit card in a window that is visible to the street and begin your improvement!

#### How to go about getting an Inspection?

**ALL INSPECTIONS MUST BE CALLED IN 24 HOURS IN ADVANCE.**

1. All inspections are marked on the inspection sheet accompanying your permit when the permit card is picked up.
2. Simply call the Building Department and schedule an inspection 24hrs prior.
3. Building Department phone number is 708/349-4887.
4. Most contractors know in advance when they will be at your house to begin work and an approximate time of when an inspection will need to be done.
5. If you are doing the work yourself, please call and give us as much advance notice as possible. The Building Department understands the limited time people have to do home improvements and will work with you on your project.

# Be Prepared for Summer Storms

Summer rains can bring flash floods. Don't get flooded and don't make flooding worse by dumping in the drainageways or obstructing drainage along your lot line. Here are some things to keep in mind:

Check with the Building Department (349-6666) on the extent of flooding in your area.

### Prepare for flooding by doing the following:

- Mark your fuse or breaker box to show the circuits to the floodable areas.
- Know how to shut off the electricity and gas to your house when a flood comes.
- Make a list of emergency numbers and identify a safe place to go to.
- Make a household inventory, especially of basement contents.
- Put insurance policies, valuable papers, medicine, etc. in a safe place.
- Develop a disaster response plan. The Red Cross and fema.gov have helpful brochures and useful information.
- Put cleaning supplies, batteries, camera, waterproof boots, etc. in a safe place.

More information on these measures can be found in the *Village's Guide to Flood Protection*. Get a free copy at the Village Hall.

**Keep Your Easement Open:** *One of the biggest causes of flooding problems in Orland Hills has been obstructions built or placed in the drainage easements that were established along lot lines. These areas were set aside to carry water away from your house without flooding your neighbors. Keep them open.*

### You can protect yourself from flooding

The Building Department in the Village Hall (349-6666) can help you with:

- Information on whether a property is in a mapped floodplain and related Flood Insurance Rate Map data;
- Records of past flooding;
- Information and copies of past Elevation Certificates;
- Free copies of the Village's Guide to Flood Protection;
- Advice on how to protect a building from water problems;
- Guidance on the laws that govern construction and property improvements; and
- Site visits to view the cause and possible solutions to a problem.

**Flood maps and flood protection references are also available at the Tinley Park Public Library.**

## REMEMBER THESE FLOOD SAFETY PRECAUTIONS:

### Flood Safety Outdoors

**Do not walk through flowing water.** Drowning is the number-one cause of flood deaths. Currents can be deceptive. Six inches of moving water can knock you off your feet. Use a pole or stick to ensure that the ground is still there before you go through an area where the water is not flowing.

**Do not drive through a flooded area.** More people drown in their cars than anywhere else. Don't drive around road barriers; the road or bridge may be washed out. A car can float in as little as two feet of water.

**Stay away from power lines and electrical wires.** The number two flood killer after drowning is electrocution. Electrical current can travel through water. Report downed power lines to Commonwealth Edison at 1-800/334-7661 ("1-800/Edison-1").

### Flood Safety Indoors

**Turn off your electricity if your building is flooded.** If you don't feel safe doing this, call an electrician. Some appliances, such as television sets, can shock you even after they have been unplugged. Don't use appliances or motors that have gotten wet unless they have been taken apart, cleaned, dried and inspected by a professional.

**Watch for animals.** Small animals like rats and snakes that have been flooded out of their homes may seek shelter in yours. Use a pole or stick to poke and turn items over and scare away small animals.

**Look before you step.** After a flood, the ground and floors are covered with debris including broken bottles and nails. Floors and stairs that have been covered with mud can be very slippery.

**Be alert for gas leaks.** Use a flashlight to inspect for damage. Don't smoke or use candles, lanterns, or open flames unless you know the gas has been turned off and the area has been thoroughly aired out. If you have questions on gas, call 1-888/642-6748 ("1-888/NICOR4U").

**Carbon monoxide exhaust kills.** Use a generator or other gasoline-powered machine outdoors. The same goes for camping stoves. Fumes from charcoal are especially deadly — cook with charcoal outdoors.

**Clean everything that got wet.** Flood waters have picked up sewage and chemicals from roads, farms, factories, and storage buildings. Spoiled food and flooded cosmetics and medicines are health hazards. **When in doubt, throw them out.**

**Take good care of yourself.** Wear gloves and boots. Wash your hands frequently during clean up. Recovering from a flood is a big job. It is tough on both the body and spirit and the effects a disaster has on you and your family may last a long time. Keep your eyes open for signs of anxiety, stress, and fatigue in you and your family.

## BUILDING DEPARTMENT

Dear Resident,

In the Village of Orland Hills it is prohibited to alter side and rear yard drainage easements and swales. The easements and swales are engineered to carry storm water to sewers and detention ponds. The elevations and grades are to be left as they were originally intended. Except for grass, no other landscaping, gardens, or building is allowed. Easements and swales that were altered should be returned to their original and intended condition.

All work over \$100.00 in value requires a permit. Examples of projects that require permits include fences, sheds, pools, decks, patios, walks, sprinkler systems, retaining walls and driveways. Any additions or alterations in electrical or plumbing work must be installed to code and also requires a permit.

## Address Numbers On Structures

Both the Village Code (150.185) and the Fire Protection District Code require that all structures must have address numbers displayed and easily visible from the street. We strongly urge each homeowner to check their home for compliance. Townhouses, Condominiums and Apartments are to be clearly marked, as well as, single family structures.

Ambulance, fire or police personnel are only able to find the right house if you help. You need to have your building number on your home.

- We recommend that the numbers be at least three (3) inches high.
- The color of the numbers should contrast with the surface.
- The numbers should not blend into the surface where they are affixed.
- Trees or other landscaping should not block the numbers.

Businesses should have their space identified in the front and the rear preferably with the business name, as well as, the space address, number or letter designation of the space.

Remember that emergency service personnel can lose time in responding to your call if they are unable to find your home. Clear identification of your home can save a life, and that life could be your own.

## RESIDENT SAFETY

### Keep Your Valuables Safe

Every day, people across America fall victim to crimes. A majority of these incidents are “crimes of opportunity”. Crimes of opportunity are crimes that are unknowingly facilitated by the victims, such as leaving your car or home unlocked. A criminal will take advantage of these situations to deprive you of your possessions.

While Orland Hills does not have a high crime rate, some of our residents and people who visit our village have been victimized by a criminal act. Many of these incidents could have been avoided by simply locking a car door or not leaving valuables in plain sight. Some criminals will steal your possessions no matter how hard you try to safeguard them.

#### Following these tips may help keep your valuables in your possession:

- Always lock your car when leaving it unattended.
- Never leave your car running unattended.
- Trim back high bushes near your doors and windows.
- Turn on outside lights and inside lights when you’re not home.
- Have a neighbor pick up mail and newspapers when you are on vacation and better yet, have them park their car in your driveway while you’re gone.
- Be creative when hiding or storing your valuables. Most people store them in the bedroom which is a favorite spot for thieves. Keep expensive jewelry in a safe or safe deposit box.
- Always record the serial numbers of valuable electronics. Take photographs of the items as well. It can help with an insurance claim.
- Place a “Beware of Dog” sign in your yard or window.
- Consider a home alarm system.
- Be observant! If you see something suspicious, or people or cars that aren’t usually in the neighborhood, call the police.

### How to Prevent Identity Theft

One of the most reported crimes today is identity theft. On average, more than 17 million people a year are victimized. It has topped the U.S Federal Trade Commission’s ranking of consumer complaints for more than 15 years.

While no one is safe from identity theft, there are steps you can take to lower your risks. **Here is how identity theft can affect you:**

- It can drain your bank account.
- It can make purchases with your credit cards.
- It can open new accounts like bank, credit cards, and cell phone in your name.
- It can get identity documents in your name.
- It can get medical care under your insurance.
- It can take out loans in your names.
- It can file false tax returns and collect a refund in your name.
- It can get someone a job in your name and have earnings reported as your income.

**How can someone steal your identity?** Some of the more traditional tactics include:

- Mail theft.
- Dumpster diving or trash theft.
- Shoulder surfing (looking over your shoulder to get your info).
- Purse or wallet snatching.

**How do you protect yourself?** Some of the ways to protect your identity include:

- Go paperless.
- Memorize your pins and passwords, don’t write them down.
- Make a list of account numbers, passwords and customer service phone numbers. Keep the list in a safe.
- Check card and bank activity regularly. Look for unfamiliar charges.
- Destroy old cards.
- Don’t give card information over the phone unless you made the call.
- Opt out of unsolicited prescreened offers of credit or insurance by mail.

- Check your credit report regularly.



Being vigilant can reduce your chances of being a victim. If you become a victim, immediately contact the police department and file a report. Contact your bank and credit companies and report new and suspicious charges.

Spayed or Neutered . . . . . \$2.50  
 Not Spayed or Not Neutered . . . . . \$4.00

Therefore, when you are coming in for your vehicle sticker in June or July, license your animals too!!

### Limit on Pets:

It is hereby declared a nuisance and shall be unlawful for any person to own more than five (5) dogs, or any combination of dogs and cats totaling five (5).
